Footnotes

QUASICOBRA tracked the pace from early on, moved to challenge leaving the second turn, stuck a head in front at the eighth pole, exchanged several bumps with KETTLE HILL the remainder, leaned in forcing FAITH'S MAGIC to take up sharply in deep stretch after the rider changed the whip to his right hand, then lapsed. CHESTERMITE went up inside to gain a slim lead early while dueling with FAITH'S MAGIC, battled on even terms into the upper stretch, fell back, swung out four or five wide in the late going and was coming again with good courage. BIGGERBADDERBETTER, never far back and near the inside, came around CHESTERMITE at the eighth pole, was steadied soon after behind FAITH'S MAGIC, slammed with that foe when FAITH'S MAGIC was forced to take up in deep stretch, bulled his way through but couldn't get up. KETTLE HILL, well in hand while stalking the pace four or five wide, inched to challenge entering the upper stretch, battled on even terms, exchanged bumps with QUASICOBRA repeatedly in the late going and wasn't good enough. IFONLYJOHNNY came out at the start bumping QUASICOBRA, was outrun to the lane, came out six wide for the drive and managed a minor gain. FAITH'S MAGIC dueled for the lead three wide, battled up close into deep stretch, was forced to take up sharply about seventy yards from the finish, bumped hard with BIGGERBADDERBETTER and was finished. ASHEN LORD weakened approaching the stretch. FOLLOWING A STEWARDS' INQUIRY INTO THE STRETCH RUN AND FOUL CLAIM BY BY THE RIDER OF BIGGERBADDERBETTER AGAINST THE RIDER OF QUASICOBRA INVOLVING THE SAME INCIDENT, QUASICOBRA WAS DISQUALIFIED FROM FIRST AND PLACED SIXTH FOR INTERFERENCE.
