## Footnotes

GRUENEWALD was unhurried into stride, advanced four wide through the second turn, angled out five wide entering the stretch and wore down his rivals in the final strides. PROVE YOURSELF stalked the pace between horses, angled out to make a bold bid four wide, forged a clear lead with a furlong to run but was turned away in the shadow of the wire. SOL A PINO was taken back under a hard hold, settled into stride along the inside, angled out entering the stretch to make his bid, lacked room between horses in the drive and settled for a minor award. GLOSS settled saving ground, angled out to launch his rally, finished with a rush but found his best stride too late. GHOST FIVE attended the pace along the inside, slipped through and loomed large entering the stretch but failed to sustain the drive. GOLD BELLS SPIN chased the pace three wide through the second turn and tired. CARNACKS CHOICE opened clear to set the pace, was collared leaving the second turn and gave way readily once headed. GREELEY'S GOLD showed little. ROCK GOLD contended four wide for five furlongs and retreated. NINTH CLIENT was forwardly placed three wide, but drifted out through the second turn and stopped.
