Weight: 122 lbs. Non-winners of a Grade I or II stakes at a mile or over allowed 2 lbs.; \$60,000 at a mile or over, 4 lbs.; two races at a mile or over other than maiden or claiming, 6 lbs. Starters to be named through the entry box at the usual time of closing. Trophy to winning owner. Closed Saturday, May 29, 2010 with 26 nominations.

### Footnotes

COLIZEO moved clear on the first turn when the runner up steadied, set a comfortable pace along the inside, responded willingly when challenged on the second turn and proved best under pressure. WORLDLY steadied once in the first turn when in close quarters, angled outside the winner, tracked that one for five furlongs, moved up to challenge on the second turn then battled the remainder while not quite good enough. VOW TO WAGER forwardly placed off the inside, could not keep pace with the top pair after six furlongs then made a solid late gain. MAX SILVERHAMMER reserved off the inside, was no real threat. PRINCE WILL I AM outrun off the rail, moved out a path approaching the stretch and was no factor. CRIDER within striking distance along the inside, tired. A FOUL CLAIM BY THE RIDER OF WORLDLY AGAINST THE RIDER OF THE WINNER FOR INTERFERENCE ON THE FIRST TURN WAS NOT ALLOWED.
