Footnotes

SIXTH AND WALNUT settled between foes three or four wide early, was put to a drive five wide nearing the final quarter, then wore down RACING RUBY under strong hand urging. RACING RUBY pressed front-running MONTREAL'S BEST from early on while four wide, took over in the upper stretch but couldn't contain the winner's surge. SAVANNAH HANNA, unhurried early, was three wide around the turn, swung out six wide at the eighth pole and offered a mild gain. RUN RATE followed the leaders four or five wide to the stretch, came out seven wide for the drive and couldn't menace while improving position. MONTREAL'S BEST gained the lead early, moved inside, made the pace until the stretch and faltered. AZURE hopped at the start, raced between rivals four wide and tired. TRACI GIRL faded inside upon going a half.
