### Footnotes

IRISH LUTE close up near the rail, angled out a bit for the drive and wore down the leader. UNO DUO vied for the lead off the inside, drew clear into the stretch but was outfinished. ANUSARA prompted the early pace outside, dropped back five wide on the turn then improved her position while no threat. FORBIDDEN within striking distance three wide, tired in the drive. BORN TO JAZZ was no threat along the inside. OUR JENNY B was no factor. I JUS WANA HAV FUN forced the pace three wide, held on well to the stretch and faded. IN KELLY'S DEFENSE prominent in the four path, also faded.
