GHOSTWALKING close up along the inside, angled out on the second turn, advanced four wide into the stretch, drifted in late under right handed pressure, bumped the runner up then edged off late. VIGILANTE LAW forced the pace in hand, gained a short lead on the second turn, battled into midstretch, steadied when bumped in deep stretch by GHOSTWALKING when that one drifted in then held the place. H. J. ARVIN alternated for the lead along the inside and tired late. BILLY forwardly placed three wide, challenged before a half, battled to the stretch and weakened. STARTINGOLD reserved for a half three wide, made a good middle move, raced five wide into the stretch and tired. RAVEN HAWK within striking distance off the inside, lacked a rally. MERCEDES CLASS angled to the inside on the first turn, failed to menace. FOLLOWING A STEWARDS INQUIRY AND A FOUL CLAIM BY THE RIDER OF VIGILANTE LAW, GHOSTWALKING WAS DISQUALIFIED AND PLACED SECOND FOR INTERFERENCE IN THE STRETCH.
