MEGAHOLTZ pressed the pace three deep, forged command midway through the second turn, edged clear entering the stretch, veered in inside the furlong marker bumping RAVEN HAWK was straightened away and held tenaciously thereafter. RAVEN HAWK settled saving ground, got through to make his bid entering the stretch, was bumped sharply when MEGAHOLTZ came in, kept on well but was unable to reach the winner. GHOSTWALKING stalked the pace four wide, launched his bid entering the stretch and was making up ground. MY PIANO MAN was allowed to settle, angled out to make a mild rally but failed to seriously threaten. HARRODS CREEK lunged at the start to get away behind his field, closed the gap four wide to offer a mild bid leaving the second turn but failed to sustain the drive. A. P. ELI set the pressured pace off of the inside for six furlongs and faded. PLEASANT AIR was forwardly placed four wide for a half and retreated. Following a jockey claim of foul and a Stewards inquiry into the stretch run, for drifting in and impeding RAVEN HAWK inside the furlong marker MEGAHOLTZ was disqualified from first and placed second.
