**Footnotes**

LADY MATTY, close up inside early, was allowed to fall back on the turn, worked her way out from between foes five or six wide in the final furlong and was under brisk urging to be along in time. ORACAT, well placed between rivals early, took over five wide in the upper stretch, opened a clear lead, then couldn't last. BEST SHOD leaned in at the start bumping COINCIDENCE, vied for the lead soon after while outside of YOU DA WOMAN, put a head in front nearing the lane but weakened in the drive. COINCIDENCE, bumped at the start by BEST SHOD, was outrun for a half, then improved position five wide with a minor gain. RED ORANGE CAT stalked the pace four or five wide into the stretch and flattened out. YOU DA WOMAN gained the lead early, battled with BEST SHOD, held on well until the stretch and faltered. MISSY GIRL failed to menace. MISS JEANNIE G. was outrun. DARLING BEE drifted out at the start, raced seven wide early, edged in five wide on the turn and faded.
