ANNABEL LEE tracked the pace three wide, took over after a half, opened clear and maintained a safe advantage. SWAKOPMUND was allowed to settle into stride, advanced between horses through the second turn, got through toward the inside entering the stretch, kept on well but was unable to reach the winner. SHANFIELD settled in hand, moved up four wide to make her bid, but lacked the needed late response. VISION OF LIZ was allowed to settle, improved position four wide but failed to seriously threaten. PARTY VOW broke a step slow, was rank to place. leveled into stride on the backstretch, was within striking distance to the stretch and tired. MOON was allowed to settle five wide and failed to respond. KLUKI was away alertly, angled in to set the pace, was headed after a half and gave way readily thereafter.
