FOR TWO YEAR OLDS. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry. \$500 to pass the entry box; \$500 additional to start, with \$100,000 added. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Colts and Geldings 122 lbs. Fillies 119 lbs. Non-winners of a race other than maiden or claiming allowed 2 lbs.; a race other than claiming, 4 lbs. The maximum number of starters for the Bashford Manor will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box preference will be given to highweiggths with consideration to the sex allowance. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner. Closed Saturday,, June 16 with 18 nominations.

**Footnotes**

CIRCLE UNBROKEN close up while off the inside, was patiently handled around the turn, challenged between rivals inside the final furlong and edged off late. POSITIVELY outrun after being squeezed early, made a run five wide midway through the turn, reached a forward position in midstretch, drifted in near the sixteenth marker then finished willingly to be up for the place. SPECIAL JO alternated for the lead off the inside, drew clear in midstretch but faltered late. HIGHTAIL angled in early tightening up inner rivals, raced close up three wide to the final furlong and weakened. GOOD TICKLED broke slowly, steadied entering the turn after gaining position, raced in the four path on the turn and tired. ROMAN'S AVENUE in tight near the half mile marker when HIGHTAIL moved in a bit, angled to the inside once in the turn, swung to the outside once in the stretch but could not threaten. PRAETORIAN PREFECT set the pace along the inside, held on well to the stretch and tired. GO JACK GO forwardly placed early, took up from between rivals entering the turn and stopped. FOUL CLAIMS BY THE RIDER OF HIGHTAIL AGAINST THE RIDERS OF CIRCLE UNBROKEN AND POSITIVELY FOR INTERFERENCE IN MIDSTRETCH WERE NOT ALLOWED.
