LAWYER GABE settled in hand, ranged up five wide to join the leaders leaving the turn, wore down BARRISTER JIM and gradually edged clear. BARRISTER JIM disputed the pace two wide, continued on well through a long drive but was unable to resist the winner. MO JO tucked in to save ground within reach, shifted out to make his bid between horses, but flattened during the drive and settled for the show. OPTIONALITY contended between horses, came four wide, lacked room near the three-sixteenths pole, altered course to the outside but went evenly thereafter. GOODNIGHT DIVA broke in the air, moved up four wide, but weakened entering the stretch and faded. SWING FA THE STARS was unhurried into stride, came three wide and finished with a belated gain. ZERO X ZERO failed to respond. HARLAN'S VITESSE vied for the lead along the inside for five furlongs and dropped out. TRACK COACH showed little. SATURDANITESPECIAL was outrun.
