CUSTERS LAST STAND reserved early, moved up four wide into the turn to a challenging position then drew clear in the drive under steady handling. CAPTAIN ON DECK within striking distance, raced three wide on the turn then finished willingly to be second best while no threat to the winner. JACK IN THE PULPIT forwardly placed, challenged three wide with a half mile to go, battled into the stretch and tired. CALL ME SIR set the pace off the inside, held on well to the stretch and tired. CRIMSON CLAY close up while off the rail, faded in the final quarter. JUSTICE HARLAN outrun early, raced five wide out of the turn and could not threaten. KENNY BOY could not menace. INFAMOUS SPIN within striking distance along the inside, faded. HE CAN HE WILL was no factor while four wide. BEHRENS SHADOW lost his footing at the start, recovered to be close up while off the inside but stopped.
