LE DAUPHIN closest to the pace inside, made a run at the leader from the two path on the second turn, dropped back into the stretch then came again late to be clear. BRILLIANT BID sprinted clear, set the pace, repulsed a bid by the winner leaving the second turn but was no match for that one late. MOGUL MAN within striking distance along the inside, angled out for the drive and finished willingly late. VEILED PROPHET outrun to the stretch, closed well on the outside. MOYER'S POND reserved near the inside, lacked a late bid. GO WEST BERT outrun early five wide, made a good four wide middle move but could not sustain the bid. RHAPSODYBOHEMIAN stumbled at the start, recovered to race within striking distance, held on well to the final quarter and gave way. CITIZEN JOHN forwardly placed three wide, moved in a path on the second turn and tired. BUREAUCRATIC four wide early, was no factor. MATTY'S TRAIL close up while off the rail, raced in the three path on the second turn and faded. DAN MCGREW was outrun.
