Footnotes

TRACI GIRL drifted out at the start, settled in behind the dueling leaders, angled five wide entering the stretch, took over, then widened when kept to her task. NAVAJO GIRL, outrun early, was angled to the rail, saved ground for a half, swung out seven wide when straightened for the drive and closed determinedly for second while unable to menace the winner. MARK OF PERFECTION ducked in at the start bumping WHAT'D I SAY, was outrun early, moved six wide on the turn, then continued off the inside for her position. RAPID RIPPLES forced the pace early while working her way in four or five wide, gained a slight lead just prior to going a half but weakened in the drive. HOT TIME, outrun for a half, raced in behind rivals, moved four or five wide into the lane and improved position while unable to menace. VERY VERY gained a slim advantage inside while dueling with TIPAZA and RAPID RIPPLES, lost the edge on the turn, continued forwardly to the stretch and weakened. TIPAZA contested the pace from between foes at once, battled close up to the stretch and weakened. WHAT'D I SAY, bumped from both sides at the start, raced 10 wide on the backstretch, edged in on the turn, made a six wide run to reach contention approaching the stretch but failed to continue. TINKER'S HOPE, sluggish to start, quickly reached contention but tired upon going a half. DWENDI, forwardly placed inside for a half, weakened thereafter. TINNERS BELLE tired early. MAJESTIC LEGS never was prominent.
