APPEALING IMAGE vied for the lead off the inside, gook over once in the stretch and slowly increased his lead while kept to the task. SATURDAY HERO forwardly placed three wide, made a mild run on the turn, reached closest to the winner once in the stretch, was no threat to that one but was clearly second best. CHAMP KAMAL close up while inside, came off the rail late on the turn and tired. IN RHYTHM steadied in the initial furlong, was outrun early, angled out six wide late on the turn when rallying, drifted in late bothering CASCI then improved his position late. HUMOR'S PUNCH within striking distance along the inside, angled out for the drive, bumped with CASCI when that one was roughed then was not a threat. CASCI steadied entering the turn, steadied again approaching the stretch behind rivals, angled out once in the stretch, bumped FOREST MEADOW, was straightened, failed to gain through midstretch then was roughed late when IN RHYTHM came in. HOLY BULLHIVE behind the leaders off the inside, moved out a bit late on the turn and tired. H. J. ARVIN

alternated for the lead along the inside, held on ell to the stretch and gave way. TAPINOT outsprinted early, raced off the inside on the turn and could not menace. FOREST MEADOW outrun early, raced in the four path on the turn, was bumped in upper stretch and tired. NO CHARGEBACK within striking distance four wide, was in tight late on the turn and faded. FREEFOURTHEROAD was outrun. FOLLOWING A FOUL CLAIM BY THE RIDER OF CASCI, IN RHYTHM WAS DISQUALIFIED AND PLACED SIXTH FOR INTERFERENCE IN THE STRETCH.
