**Footnotes**

PLENTY gained the lead early, raced two or three wide under careful handling, leaned in slightly brushing with MODENA BAY (NZ) about the sixteenth pole and proved best under strong hand urging. MODENA BAY (NZ), rated near the rail from early on, edged up entering the stretch, lacked room briefly nearing the final sixteenth, brushed with the winner, then couldn't get up when clear very late. MISS NASHWAN (IRE), unhurried early, raced near the inside, came out five wide for the drive and was going well at the end. BEAUGESTE gained a forward position three or four wide, continued within easy striking distance into deep stretch and failed to fire. AMANUENSIS, briefly in front after the break, eased out four wide on the first turn to press the winner, continued up close into the final furlong and weakened. IMPERIAL GRACE raced near the inside and was empty in the drive. UNBRIDLED ECHO bobbed at the start, raced in contention five wide to the stretch and came up empty. VALLERA (GER) failed to menace. SHOREY VILLAGE raced four wide and tired on the far turn. A FOUL CLAIM LODGED BY THE RIDER OF MODENA BAY (NZ) AGAINST THE WINNER FOR ALLEGED INTERFERENCE IN THE STRETCH RUN WAS DISALLOWED.
