HILLY M settled saving ground, launched her bid leaving the turn, reeled in OUT COLD and drew clear in the final yards. OUT COLD sprinted clear to set the pace, weakened entering the stretch, drifted out through the drive and was unable to resist the winner. BUDDHAS BLESSING was unhurried into stride, got through to make her bid entering the stretch and was along for the show. PRINCESS LAURIE was allowed to settle, came four wide to make a mild bid but lacked the needed late response. BARBATINA settled in mid pack, made a mild rally circling six wide but failed to threaten. MORE THAN THOUGHT was forwardly placed between horses four wide, but weakened leaving the turn and faded. BLACK DRESS was unhurried early, swung seven wide to make a belated gain but was never a factor. SASSY WEASEL hopped at the start and passed only her tiring rivals. SKIPPY O was unhurried off of the inside and failed to respond. LEGAL MOTION raced wide and showed little. PRINCESS MARQUETRY was hustled along four wide for a contending position through

the turn and dropped out. U. S. BONDS chased the pace off of the inside for six furlongs and stopped.
