Footnotes

UFFIZI, never far back while following the leaders four or five wide, was put to a drive at the five-sixteenths pole, then while coming a bit wider in the late going, was fully extended to capture a there-way photo for win. TRANSDUCTION GOLD, well placed three or four wide, took over approaching the final quarter, was engaged by the winner from the outside entering the stretch, held on stubbornly but was out-nodded. FONGTASTIC (GB), unhurried to the far turn, raced three wide, move between horses when rallying five or six wide around the far turn, was going well at the end but couldn't get up. BACETTO, outrun to the end of the backstretch, moved five wide on the far turn, fanned eight wide for the drive and improved position. CHISLEHURST, rated along early and three wide, edged closer nearing the lane, angled seven wide, then could gain only slightly in the late going. DANDY GENTLEMAN, up close inside early, eased out three or four wide on the backstretch to force the pace and weakened approaching the stretch. DRILLING FOR OIL gained the lead early while two or three wide, edged to the rail on the backstretch, held on well until approaching the stretch and weakened. HIGH OCTANE bobbled sharply at the start, gained a forward position near the inside, eased out three wide leaving the second turn and was empty. GRAND TRAVERSE swerved out at the start bumping the gate, bobbled, was taken in hand and positioned in behind horses three or four wide, raced in contention for seven furlongs and weakened. DYNAMMAN raced four wide and tired entering the far turn.
