ANOTHER TRICK stalked the pace three wide, assumed command entering the stretch and steadily drew clear. CANDY CAT CAN settled saving ground, closed the gap through the turn, got through entering the stretch and finished well to prove second best. LILLIAN GISH was allowed to settle, commenced her rally circling five wide and was along in time to earn the show. SURF DIVA opened clear to set the pace, was collared leaving the turn, stayed on to the final furlong and faded. KEEPINGTHEPROMISE settled in hand, moved up four wide between horses but failed to seriously threaten. RUE SAINT HONORE was close up three wide, offered a mild entering the stretch but failed to sustain the drive. CHEER N SHOUT broke slow, was unhurried into stride, finished with a belated gain but failed to threaten. EARTH'S APPEALING settled off of the inside, angled out entering the stretch but lacked a response when called upon. WHISPER LAKE was fractious to load and flipped over unseating the jockey, broke slow and was never a factor. MAMA DECIDES was close up four wide through the turn and stopped. LACY RUFFLES was through early.
