RUSH IN broke slow, was unhurried and tucked in to save some ground, worked his way forward between horses, shifted to the outside in the final sixteenth, quickened once clear and was up in the final strides. BARRY SHORTPANTS attended the pace along the inside under a snug hold, split horses leaving the second turn, forged a narrow lead with a furlong to run, continued on willingly but was unable to resist the winner. DE ENFORCER tracked the pace three wide, took over midway through the second turn, but weakened during the drive and settled for the show. UNBRIDLED LOGIC was allowed to settle, circled five wide to make a mild bid, but lacked the needed late response. DUELING OAKS opened clear and set the pace along the inside, was collared after a half, disputed the issue to the stretch and faded. PRINCE STEVIE contended between horses, angled in entering the stretch but came up empty in the drive. GRAND KUMA made a middle move five wide, offered a mild bid but failed to sustain the drive. WINNING VOWCHER broke awkwardly, was unhurried along the inside and was never a factor. SECRET CITIZEN showed little. NAVAJO CA LO was hustled along five wide for five furlongs and dropped out.
