Footnotes

PRIVATE GENTLEMAN within striking distance off the rail, split rivals leaving the turn, challenged in midstretch and proved best under pressure. VALHALLA steadied when in tight and bumped at the start, swerved out five wide once in the turn to avoid CHOP'ARRABBA, advanced four wide late on the turn, drifted in in midstretch when moving to challenge then was outfinished. E FACTOR carried wide near the half mile marker, forced the pace outside, held on well to midstretch and tired. BONWELL close up while between rivals, was carried out near the half mile marker, recovered, stayed on well to midstretch and tired. SIR STRIKING bumped and forced out at the start, angled out eight wide once in the turn, remained back to the stretch and made a late gain. SHERIF drifted out at the start, recovered to race within striking distance five wide but tired. WOOLLY WALKER angled out seven wide with three furlongs to go, was no threat. MAGIC DE NASKRA vied for the lead along the inside and tired in the drive. YANKEE DON carried out near the end of the backstretch when with the pace, alternated for the lead into and around the turn, held on well to the final furlong and tired. STREET HUSTLE drifted out at

the start and bumped SIR STRIKING out, raced seven wide with three furlongs to go and could not menace. JAKE THE SNAKE carried out near the half mile marker, forced pace five wide, was in tight in midstretch and tired. CHOP'ARRABBA sprinted clear and angled in, drifted out near the half mile marker then was eased on the turn when lame.
