### Footnotes

SON OF A GENERAL within striking distance inside, moved off the rail on the backstretch, angled out for the drive and closed well to be up in time. STAY PUT reserved three wide, moved up in that path after a half, challenged once in the stretch, gained a short lead inside the final furlong but was outfinished. TYCOON set the pace inside, responded willingly in the stretch after moving off the inside and held on gamely. WEALTH TO ME forwardly placed off the rail, lacked a late bid. WATCH MY SMOKE closest to the pace while off the inside and in hand, challenged on the second turn and held on gamely. SUN BEAR within striking distance, raced in the four path on the second turn and tired.
