FLEUR DE LILLY set the pace along the inside, took over once in the stretch and drew off under steady urging. HANNAH MISSISSIPPI rushed along the inside, raced close up inside, waited late on the turn, angled out once in the stretch but lacked a late bid. TRIPLE GREAT within striking distance off the inside, angled out five wide leaving the turn for a clear path but lacked a late bid. OUR CAREER MOVE prompted the pace three wide, held on well to the stretch and tired. MY GLITTER GIRL within reach while in the four path, had nothing left in the drive. STONESEZ outrun from the start, raced in the three path on the turn and rallied belatedly. TEASE POINTS was no threat three wide. DEVILISHLY WILD reserved early, raced in the five path on the turn, came six wide into the stretch and weakened. HOLD THAT PLACE broke slowly and was no threat while along the inside. LEXI'S READY forwardly placed off the rail, raced in traffic in upper stretch and faded. MERAB forced the pace off the inside, held on well to the stretch and faded. CASTLE DREAMER was outrun.
