VEILED PROPHET unhurried while outrun, closed the gap after a half with a good middle move, was patiently handled into the stretch, accelerated when a clear path became available with a furlong to go, challenged with a sixteenth to go and proved best late. WHITLEY reserved along the inside, moved up along the rail after five furlongs, challenged in midstretch and held on gamely. ORDINATION (IRE) forced the pace off the inside, challenged on the second turn, gained a short lead with a furlong to go and held on gamely. FORESTRY TYPE within striking distance four wide, lacked a rally. CALIMONCO reserved three wide, made a mild middle move, reached a forward position approaching the stretch but tired in the drive. QUITE A HANDFUL set the pace along the inside, held on well to the stretch and tired. UNBRIDLE'S DREAM prominent three wide, stayed on well to the stretch and faded. PROVE YOURSELF was no factor. ARTIC CRY within striking distance off the inside, moved to the rail midway through the second turn and stopped.
