GRAND ILLUMINATION stalked the pace four wide, assumed command entering the stretch and drew away to score as the rider pleased. NOCTIVAGANT was allowed to settle, circled into the stretch six wide, veered in with a furlong to run, found room and kept on fairly well to earn the place. BRIKSDAL sped clear to set the pace, was collared entering the stretch, gave way but had enough left to hold the show. DANCING RUTH settled in hand, moved up five wide to make a mild bid but failed to sustain the drive. STARUNNA was allowed to settle, came four wide between horses but lacked a response when called upon. NORTHERN CHILL pulled four wide, checked repeatedly from the half mile marker to the seven-sixteenths pole, shifted out six wide to be clear

but showed little thereafter. GOSSIP BAY contended between horses through the turn and faded. SYN NO MORE saved ground to no avail. IMUSTBEPERFECT was forwardly placed along the inside, but faltered in the final furlong and faded. ROBIN SUE showed little. MIST IN THE MORN was through early. MY CHEYRONA flipped prior to loading, broke in the air to get away well behind her field and trailed.
