**Footnotes**

STRAWBERRY AFFAIR moved clear soon after the start, raced near the inside while controlling the pace, repelled an earnest challenge from CORPORATE STORM a quarter-mile out, reopened a clear advantage, then was ridden hard to hold KICK BOXER (FR) safe. The latter, unhurried early and saving ground much of the way, angled outside the winner three wide in the final sixteenth and slowly was gaining. IMAGE, outrun until the stretch and saving ground most of the trip, improved position but couldn't menace the top two. DAKOTA PROSPECT, forwardly placed between foes three or four wide into the stretch, was empty the when the test came. CORPORATE STORM went up early to press the winner from the outside four wide, gained almost even terms with that one a quarter-mile out but failed to continue. SIDE BRUSH, five wide in a contending position for six furlongs, was empty thereafter. ROSE CREEK, within easy striking distance while stalking the leaders four or five wide into the stretch, flattened out in the drive. LAKE AUSTIN, slow to begin, was outrun.
