COURT'S JOURNEY tracked the pace three wide, forged command leaving the turn, fought on well and was all out to just last. GRUENEWALD was unhurried into stride, tucked in to save ground, got through entering the stretch, finished well and was gaining with every stride. ROMAN ALONG opened clear to set the pace, was collared after a half, gave way but had enough left to hold the show. HERO'S EMPIRE was allowed to settle, angled out leaving the turn, came six wide between horses and improved position. BLUE CHERRIES SPIN broke slow, was unhurried, circled seven wide and was making up ground. FIJI STAR (ARG) settled between horses but lacked a response when called upon. SIR JOCK saved ground to little avail. JERSEY DEVIL contended five wide through the turn and faltered. ROCKY BEAR failed to respond. RULER NEKIA was close up between horses for a half and tired. SIR

SHAUN was through after a half. HOMETOWN LEGEND was jostled at the start and was never a factor.
