COURTROOM DRAMA outrun for a half, made a good middle move off the rail, angled out in midstretch and finished well to be up late. DO YOU LIKE MONEY prompted the pace three wide, challenged on the second turn, took over in midstretch but was outfinished. LORD MIKE alternated for the lead off the inside, dropped back in midstretch then was coming again late. AVENUE B clipped heels and stumbled early, was outrun for five furlongs, angled out for the drive and made a late gain. THE ONE THING broke in the air, was unhurried early, made a four wide run on the second turn, reached a forward position in midstretch but weakened. MACK DADDY SLADE forwardly placed three wide, lacked a late bid. CHANT MY NAME reserved early, made a three wide

middle move but could not sustain the bid. IL MOSTRO set the pace inside, held on well to the final furlong and tired. PROUD WARRIOR was no threat while off the inside. A. P. ELI forwardly placed along the inside, gave way. RAILROAD ROY within striking distance off the rail, was through after a half. RIO WYNN four wide early, was no threat.
