Footnotes

FACE THE FIRE broke sharp, was reserved off of the lead under a snug hold, drew even nearing the five-sixteenths pole, poked his head in front entering the stretch and gamely edged clear late. GUARDED ENTRANCE set the pressured pace along the inside, was headed entering the stretch, was unable to resist the winner but fought on stubbornly to earn the place. BIG TALL PAUL was fractious in the gate, settled in hand, moved up between horses on the second turn, angled in entering the stretch and was just up to earn the show. Z APPEAL stalked the pace three wide, came four wide to make his bid, but flattened between horses in the drive and finished evenly. OLYMPIST was allowed to settle, circled four wide through the second turn, loomed a danger entering the stretch but failed to sustain the drive. EDDIE SET GO was forwardly placed along the inside, got through entering the stretch but came up empty in the final furlong and faded. CAT SHAKER was outrun.
