EYEESEYOU vied for the lead three wide, took over entering the stretch and quickly drew clear. GOLD'N HOLIDAY was allowed to settle, circled five wide and finished willingly to earn the place. WILDCAT COUNTRY veered in at the start bumping NINJA CAT, was straightened away and rushed to the lead, set the pressured pace through the turn, weakened in the drive but had enough left to hold the show. SHUT DOWN CORNER settled saving ground, got

through to make a mild bid but lacked the needed late response. TENACIOUS TIGER was allowed to settle, came five wide and improved position through the lane. HUNTERWOOD POINT was allowed to settle between horses, finished with a belated gain but failed to threaten. AEGISADVANTAGE was close up four wide through the turn and tired. TIEMPO LIBRE saved ground to no avail. NINJA CAT was jostled between horses at the start, recovered quickly and moved into contention, but came up empty before going a half and faded. GRANITE HARBOR was bumped at the start, was forced in and hit the temporary rail in the chute, dropped far back and lost his best chance. PALADIN'S FURY showed little. MIKES DIXIE DANCER was outrun. Following a Stewards inquiry WILDCAT COUNTRY was disqualified from third and placed tenth for veering in and bumping NINJA CAT and forcing GRANITE HARBOR into the temporary rail.
