BRAHMS SONG stalked the pace racing three and four wide, bid five wide into the lane and gamely prevailed. HIGH SPEED JUSTICE bumped with a rival at the break, moved to a short lead racing out from the rail, resisted through upper stretch then was worn down while holding clear for the place. ZENA'S AFFAIR stalked the pace from three wide to challenge in late backstretch, continued to vie into the lane and was outfinished for position late. ONE CAR FUNERAL moved up five wide into the lane but could not threaten late. SARATOGA EMBER followed the pace in good position but lacked a solid bid. LIBBYS LITTLE HAWK broke inward to bump with a rival, stalked the pace from three wide and lacked a bid. LYNNIES TREAT moved by tired ones while not a threat. BEAUTIFULBROWNEYES followed the pace racing four to five wide and tired. LYNAE DAWN was caught in tight quarters between rivals into the first turn, checked and was shuffled back, saved ground and never threatened.
