FIRE UP THE BELL settled back off the pace racing four wide, rallied five wide in the far turn to bid and edge clear into the lane then held safe under steady handling. MONEY TO BURN stalked the pace racing four and five wide, angled in going to the far turn with his bid then could not get to the winner in the drive. KIMURA contested the pace outside MR. MCGAUNASH while four and five wide, swung outside the leaders once clear entering the lane and lost some ground. HOWARD COUNTY HANK saved ground while trailing to the far turn, angled four wide in that bend to rally but was too late threaten. TRANSEPT'S AFFAIR saved ground and tired. MR. MCGAUNASH contested the pace inside KIMURA while out from the rail, came to the four path entering the backstretch and tired nearing the far turn.
