MY SECRET STAR was allowed to settle early, moved up three wide to take command and drove clear in the final stages. HOWARD COUNTY HANK was slow early, moved up four wide into the upper stretch and finished second best. TURBO ENERGY pressed the pace and weakened in the drive. HALO'S ROCKET showed good speed from the inside and weakened a bit in the drive. SWEET BOY was in tight early, stalked the pace from the inside and tired. LARRYLARRYLARRY showed little.
