HIGH SPEED JUSTICE bumped with a rival at the start, soon sped clear racing along the inside then drew off under steady handling in the lane. SARATOGA EMBER stalked the pace from three wide, moved inside on the far turn and continued on to gain the place late. ZENA'S AFFAIR stalked the winner from three wide and lacked a final closing response. ONE CAR FUNERAL was five wide through the first turn, settled four wide and moved up in the far turn then could not threaten late. NO ICE PLEASE stalked the pace from four wide in good position then lacked a late bid. BEADED was not a threat racing four and five wide. BEAUTIFULBROWNEYES followed the pace in good position while three to four wide and weakened. TWO STEPPIN TESS saved ground and was always back. ABDUCTED LADY broke outward to bump with a rival, followed the pace in good position along the inside and tired.
