Footnotes

RUNSANDYRUN forced the pace from outside OPERATOR ERROR to challenge into the far turn, continued inside and needed her best late to hold safe. SHADE ON stalked the pace from three wide to bid into the lane then drifted out through the final sixteenth and narrowly missed. DEPUTY'S WHIRL rallied four and five wide in the far turn to have aim, drifted out some nearing the lane then drifted more through with the rider losing his whip around the sixteenth marker. OPERATOR ERROR made the pace from along the inside while pressed by the winner, continued well but was outfinished for position. WA HOO ANGEL stalked the leaders from along the rail and continued well in the lane as the field bunched on the wire.
