### Footnotes

PETITION FOR GOLD made the pace from along the inside while pressed throughout, angled out into the lane and edged away under steady handling. EL CORDERO forced the pace outside the winner throughout and could not match strides late. GRAND AVENUE saved ground in good position but lacked a final closing run. JOKIN N SMOKIN stalked the pace from three wide and lacked a final closing bid. HE CAN DO THAT saved ground, moved to leaders into the far turn but awaited room entering the bend and then again nearing the lane and could not mount a further rally. BOOTSCOOTN EXPRESS drifted six wide into the first turn, followed the pace from outside and weakened. ILE ST. FRANCES lacked a bid racing four and five wide. MISTER SUH trailed racing outside.
