SHE AROSE dueled from inside OPERATOR ERROR while racing about the three path, kicked clear late in the far turn and drew off while roused through the lane. SHADE ON settled back off the pace racing three wide, angled out through the lane and rallied from midtrack to gain the place late. WA HOO ANGEL saved ground while content to the follow the leaders then could not save position late. OPERATOR ERROR dueled from outside the winner to late in the far turn and had little left in the drive. DEPUTY'S WHIRL saved ground and failed to mount a bid. PHIL'S LITTLE GIRL was very rank after the break, fighting the rider for the opening several jumps and never gained contact with the field.
