HUMDINGER stalked the pace, rallied to lead at final fence, prevailed in stretch drive. SWIMMING RIVER was off quickly, led till final fence, held well, giving a good effort. SILENT VOW rated nicely, gave chase from final turn to wire, giving a good effort. SILENT VOW was disqualified and unplaced for failure of jockey to weigh in. CHANGE COURSE stalked the pace, gave chase but unable to overtake competitors. FANTORINI went unhurried early, bid wide on turn, then faded. JUNOOD trailed.
