Footnotes

MS MILLIE ROBBINS lacked speed while racing four wide, advanced five wide nearing the lane, closed steadily through the stretch, got up inside the sixteenth pole and pulled clear. LOOKIN FOR ANSWERS prompted the pace from the rail, bumped SEEING DOUBLE entering the turn, stalked the pace inside around that bend, took the lead in upper stretch, quickly drew clear, led past the sixteenth pole but could not last. ROLLICKING RUBY disputed the pace two wide between foes around the turn and was outfinished. ANNKATHRIN was unhurried in the two path between foes around the turn and rallied inside in the stretch to just miss third. GO TWINKLE GO pressed the pace three wide between rival and weakened on her left lead through the lane. HAVANAFANTASY saved ground early, swung four wide near the five-sixteenths pole and lacked the needed rally. LINEUP stalked the pace three wide and lacked a closing bid. GREEK GIRL saved ground to no avail. AIDEN'S LIL DEVIL vied four wide and faded. MIKA'S SNOW FLAKE stalked the pace three wide between rivals and tired. GARDELLA bumped with SEEING DOUBLE just after the start, raced four wide around the turn, checked nearing the quarter pole and dropped back. SEEING DOUBLE bumped with GARDELLA just after the start, flashed speed between rivals down the backstretch, was bumped and forced to check entering the turn and quickly retreated from there. The rider of SEEING DOUBLE claimed foul against ROLLICKING RUBY for

alleged interference entering the turn but the Stewards found no reason for disqualification.
