### Footnotes

FESTIVO, taken to rate off the rail, moved closer nearing the quarter pole, drifted out a bit leaving the eighth pole, was straightened away, rallied between foes to take command a sixteenth out and proved best under a drive. AFTERNOON JAZZ settled back early, advanced four to five wide into the far turn, circled five wide into the lane, brushed with the winner leaving the eighth pole, raced on his left lead, came in a bit late and was outfinished. LUCKY GARCIA dueled early along the inside, moved clear under rating nearing the half mile marker, opened up two wide under a ride in upper stretch, drifted out nearing the sixteenth pole and tired. DEVIL OF A DEAL settled off the rail, made a two wide run into the lane, angled out and lacked a solid finish. WHATADANCE settled inside, swung five wide for the drive but failed to menace. ISLAND DREAMING, sluggish away, lagged well back, saved ground into the lane but failed to threaten. PLATINUM MISSILE saved ground nearing the far turn and weakened. FREE CANDY was used four wide early, pressed the pace three to four wide to the far turn and faltered. CRUISE OUT FRONT vied between early and faltered. An objection by the rider of AFTERNOON JAZZ against the winner for alleged interference in the stretch was not allowed
