Footnotes

CHOIR OF ANGELS quickly gained between runners mid turn, angled out four wide, rallied to command a furlong out, drifted in briefly, was corrected with the left stick and held firm. SPUNKY COUNTRY GAL saved ground while settling off the early pace, eased out a path leaving the far turn, shifted out five wide for a clear run into the lane and closed up nicely. LOCUST TRACE rated early off the rail, moved up off the inside into the stretch, steadied off heels in mid stretch, recovered and kept on with interest. SPUNKY CAT had aim along the inside, angled out entering the stretch, steadied in tight quarters in mid stretch then faded. STAR LEEN dueled two wide, gained a short lead in upper stretch, was headed a furlong out and weakened. BELL DRIVE , in range along the rail mid turn, lacked a rally. CONFEDERATE JAZZ , off slowly, lagged back, angled in past the eighth pole and had a belated response. BALLET DANCER broke sharply, dueled along the inside and tired in the final furlong. MAKE BELIEVE STUNT , wide, dropped back. ENGLISH ARMS , three wide disputing the early pace, began to fade near the quarter pole then steadied briefly entering the lane. JACKADEE broke slowly, saved ground into the stretch

and failed to menace. WALKINGINTHERAIN moved up five wide soon after the break, gave chase continuing very wide around the turn then faltered entering the stretch.
