Footnotes

SURPRISE ME rated off of a contested and quick early pace, swung out four to five wide in upper stretch, closed relentlessly under left handed pressure and forged ahead in the final jumps. GRAND VIZIER sprinted clear early three wide, dropped towards the rail nearing the turn while joined from the outside by KING OF THE FAERY, dueled, lost command mid turn, battled back to regain command into the stretch, kicked clear, ducked out from left handed rousing near mid stretch then just failed to last. KING OF THE FAERY moved up outside GRAND VIZIER nearing the turn, dueled and moved to a short lead mid turn, drifted out despite right handed pressure entering the stretch then faltered through the final furlong. GOINGPOINTOPOINT chased along the inside and came up empty. I'M WITH CONAN chased between runners leaving the far turn and tired. BIG RUSH broke in a tangle, lagged far back, raced wide and trailed. SURPRISE ME WAS DISQUALIFIED FROM FIRST TO UNPLACED FOR A MEDICATION VIOLATION.
