Footnotes

RICHIE THE THIEF raced along the rail into the turn, swung three-wide near the five-sixteenths pole, came six wide into the lane and closed strongly on the outside. QUARRY LAKE dueled along the rail, drew clear in upper stretch, held clear past the eighth pole, could not resist the winner but held well for the place. SONNY B CRUISIN' stalked the pace while racing just off the rail and in the clear, angled three wide in upper stretch and lacked the needed rally. HIGHBONTHEHOG dueled three wide around the turn and weakened in the lane. LITTLE JOE EXPRESS lacked speed while racing between rivals around the turn and mild stretch run between foes. PRANKSTER JACK settled off the pace in the two path, swung seven wide nearing the lane then flattened out. FREE CANDY lacked speed inside, swung to the far outside in midstretch and rallied belatedly. GIVE ME SILVER was never a factor. SILVER BAY was off slow, raced three wide around the turn and lacked a late response. MO'S BRO dueled between rivals around the turn and tired in the drive. GET IT IN INK was outrun.
