### Footnotes

EZ MAC settled early, advanced between rivals under some rating nearing the lane, closed determinedly under left handed urging and wore down WESTMORELAND in the final yards. WESTMORELAND, taken to rate while saving ground early, moved closer into the far turn, eased out and lodge a bid between rivals leaving the far turn, took command approaching the lane, kicked clear in mid stretch then gave way grudgingly. TO SENDER (GB) stalked the pace, lodged a three wide bid between rivals leaving the far turn, disputed the pace into the lane then could not match strides in the final furlong. RESCIGNO lagged inside, swung out wide in the drive and had some belated action. WYE moved up four wide nearing the far turn, lodged a bid near the three eighths pole, forced the issue to the quarter pole and weakened. TERRIFIC TOM rushed clear early, set the pace towards the inside, took pressure leaving the far turn then tired in upper stretch. PITCHNICHOLAS failed to menace. PLEASANT PICK was outrun.
