Footnotes

FRATELLO lacked speed, advanced in the five path entering the far turn, closed outside the leader to take command approaching the eighth pole and edged clear under pressure. ORCHESTRA LEADER brushed with NO OFFENCE soon after the break, was well back early, swung wide for the drive and rallied. NO OFFENCE brushed with ORCHESTRA LEADER soon after the break, was between horses leaving the backstretch, steadied in traffic near the three eighths pole, found room along the rail through the stretch, reached a striking position in midstretch but failed to sustain his rally. DUNCANS CIRCLE, never far back, was off the rail for the drive and failed to rally. MR. STARR'S REPORT saved ground the first turn, was four deep entering the far turn and gave way before going six furlongs. JUDGE WYLIE set the pace in the two path, faltered and drifted wide inside the eighth pole. B J'S GIBSON, three wide the first turn, chased the pace to the far turn and stopped after six furlongs.
