### Footnotes

BROADWAY DREAMER rated close about the three path through the backstretch, took aim into the turn, dueled to the lead nearing the quarter pole and dug in under steady handling to maintain. UNLEASH THE FURY settled off the pace about the four path, eased to the outside entering the stretch and got up late for place. CHLOE CAROL rated a short lead through the backstretch, contested the turn about the three path, relinquished control at the quarter pole and was outfinished late for place. UNSPEAKABLE stalked the pace inside, contested the rail through the turn then faded from the quarter pole. CAYENNE LADY rated off the pace inside, had aim at the top of the stretch, eased out from there but leveled off the final furlong. PORCH SITTING and CALL OUR GIRL were not factors.
