Footnotes

LADY INDISCRIMINAT lightly steadied on the heels of SPECIAL COYOTE near the five sixteenths pole, was angled to the rail leaving the turn, eased outside in midstretch, closed, drew out and lugged in late. SERVE TOO stalked the pace, was three wide leaving the turn, gained a clear advantage in midstretch and weakened in the drive. FOREST HUSH lacked speed, was wide entering the stretch, lugged in under right hand whipping near the eighth pole and closed late after switching to her right lead in deep stretch. MOONLIGHT RAFFLE , angled to the rail entering the stretch, had a slight rally. TRIPPED IN A CREEK , wide leaving the turn, was not a late threat. PEACEPHILLY set the pace along the rail and gave way. SWEET TEMPTATION prompted the pace, gained the lead approaching the stretch and gave way the final furlong. CHAPADA , outrun, raced along the rail in the stretch. VICUNA PRINCESS was not a factor. SPECIAL COYOTE had speed two wide and faltered leaving the turn. MY LADY IN RED trailed.
