VENTURE CAPITAL sprinted clear to set the pace in the two path, held clear past midstretch, switched back to his left lead near the eighth pole, weakened and lasted under steady right-handed urging. WILD MAN WALKIN chased the pace inside, angled out in upper stretch and steadily gained on the winner through the final eighth of a mile. STORMIN YANK chased the pace two wide between rivals around the turn and faded while continuing on his left lead in the stretch. MY STREET chased the pace three deep around the turn and lacked a response.
