AFTERNOON JAZZ saved ground while taken to rate early, steadied nearing the quarter when advancing, angled out and split horses leaving the three sixteenths marker, closed determinedly under left handed urging, forged to command inside the sixteenth pole and drew clear. BARLIV lodged a three wide bid nearing the turn, dueled to upper stretch, kicked clear in mid stretch, continued willingly but was no match late. COMEBACK PAPA , a bit fractious pre race, chased the pace three wide and rallied mildly. FREE CANDY , off the rail, was lightly steadied mid turn, swung out seven wide for the drive and had some belated action. AWESOME TORNADO gained command between rivals, was joined nearing the turn, dueled to the three sixteenths marker then weakened in the final sixteenth. WESTERN ACCENT chased the pace while saving ground and weakened. LEGGS AN LIGHTNING , sluggish from the gate, came five wide for the drive and failed to threaten.
