FOUR SCHOOLS (IRE) stalked the pace, gained the lead on the backstretch the final time, pulled away under brisk urging in the drive. CLASS SHADOW unhurried early, circled horses the final turn and rallied. DUKE OF EARL (IRE) lacked speed, raced outside horses and rallied. FREE ADMISSION failed to rally. DR. BLOOMER chased the pace and weakened. MOTEL AFFAIR was no factor. RUN THE LIGHT lacked speed and was outrun. PLEASANT PICK was outrun. CHESS BOARD (GB) was eased and left the course. SUNSHINE NUMBERS opened a long lead, tired, was eased and left the course. SWIMMING RIVER left the course. SOUND BLASTER (IRE) fractious before the race, refused to start and following a stewards' inquiry, was declared a non-starter.
